About this Race: Starts at 8 p.m. at McAllister Park Pavilion 2, 13102 Jones Maltsberger Rd. with post-race party at Momak's Backyard on 13838 Jones Maltsberger Rd., San Antonio. Runners will follow trail marked with orange marking tape, arrow signs and glow sticks. There will be 1 water stop approx half way. The trail varies from straight and smooth to windy and very rocky with many tree roots. Headlamps or flashlights are REQUIRED as you will run through pitch dark, heavily wooded trails. All runners will receive technical shirts, excellent support, a burger, fries and drink and free cold beer while it lasts. There will be a post race Valentine's mixer and raffle inside of Momak's after the race. This is a fun run so we will not have awards.
