FEES: Kid Mile: \$20 and \$25 on race day 5K: \$45 through 3-26, \$55 through 4-12, \$65 after that and \$70 on race day. 10K: \$50 through 3-26, \$60 through 4-12, \$70 after that and \$75 on race day. MILITARY/POLICE/FIRE DISCOUNT: \$5 discount via mail in registration only; copy of ID required. RACE HOTEL: La Quinta Inn & Suites, www.laquintaspi.com and Hilton Garden Inn, 1-956-761-8700. They are next door to each other. Ask for Sand Crab Rate.

ABOUT THE RACE: Run or walk under the stars on a beautiful South Padre Island beach. Flashing yellow lights and glow sticks mark the course. *IT WILL BE DARK: you MUST bring a headlamp/flashlight.* The course starts at La Quinta Beach Resort and runs south before turning around and heading back to the finish. **Both the 5K and 10K have a 2-hour cut off;** all runners must reach their turnaround within 1 hour. Aid stations feature HEB Quench sports drink and water; 10K runners hit aid stations 4 times, 5K runners hit aid stations twice. After the run, enjoy catered BBQ, cold beer (for ages 21 and up) and music at the finish line. Extra BBQ plates available by pre-order for non-running guests for \$15.

REFUNDS AND RAIN: There will be no refunds for this race. The race takes place rain or shine. Race may be delayed or cancelled if hazardous conditions such as flooding or lightning are imminent.
